Chapter Committee Reports:

Young Eagles: Ralph stated that the Young Eagles Fly-Out held in cooperation with the Tuskegee Airmen was successfully held July 21, 2012, at Glenn Austin's hangar.

National EAA has announced a new program for promoting aviation called the Eagles Program. It is a separate event, not to be conducted at the same time as the current Young Eagles events.

It is for people 18 years or older that are very interested in becoming pilots. The chapter's pilots will act as "Mentors" to these individuals. As a pilot, you will take this individual flying, mentoring them before, during and after the flight. The national EAA will be sending the Registration Forms for both the pilot and individual to complete. When the National EAA receives the completed form, the individual will be given a 6 months membership in the National EAA organization. Ralph has already requested the Registration Forms for the Chapter.

Fly-Outs and Social Events: Lynn Munroe confirmed that there is a Fly-Out to Valle, AZ scheduled for August 25, 2012.
